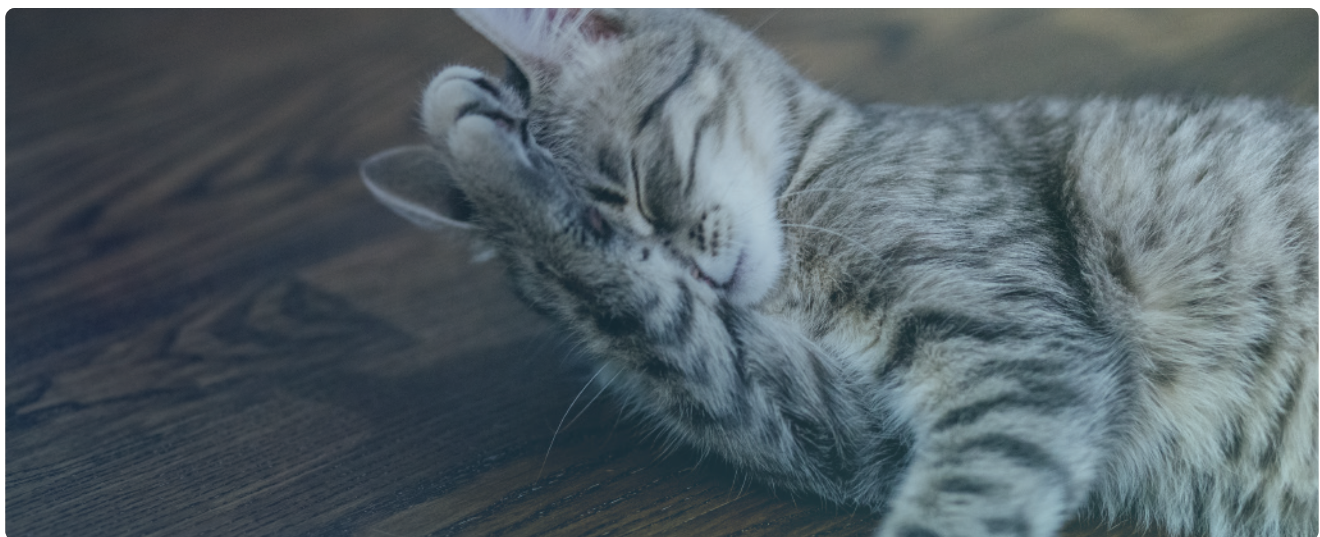

Veterinarians Appreciate Compounded Medications

Compounding pharmacies fill prescriptions that are unavailable commercially in response to a licensed veterinarian's order.

- There are four types of compounding that are important to veterinarians:
- Providing an appropriate therapy that would not otherwise be available for a specific animal;
- Preparing custom strengths or dosage forms of medications to meet the wide range of animal requirements in veterinary medicine;
- Compounding one dosage form into another, such as a capsule to an oral suspension;
- Flavoring a medication to improve compliance.

Compounding is Appropriate When...

Compounding is appropriate when:

- The best therapy for an animal is not commercially available.
- The active drug ingredient is not available in the desired strength or dosage form.
- A commercial product is on extended back-order, and using the compounded preparation may prevent an interruption in proven therapy for an animal.
- The manufacturer has discontinued the product for human safety reasons, but the medication is a life-saving therapy for veterinary species.
- Animal/owner compliance may be improved through the use of animal-friendly flavoring and alternative dosage forms, resulting in better treatment outcomes.
- A new therapy reported in veterinary literature is not available commercially.
- The manufacturer, for non-safety reasons, has discontinued a commercial product. The animal is sensitive or allergic to a non-active component of a manufactured product (e.g., lactose, dyes, or preservatives).

Compounding is NOT appropriate when:

- A treated animal is in the human food chain. It violates patents.
- A compounded version of a commercially available product is being used just to save money.
- Exposure to the preparation would create unsafe conditions for the compounding staff, veterinary staff, or pet owners.
- A suitable manufactured product is commercially available.
- Producing the compound is beyond the skill set or equipment capability of the compounder and/or its laboratory. A good compounding pharmacist will decline to prepare a medication beyond the scope of their expertise.

Ear gels and specially flavored oral medications are just some of the solutions our pharmacy can provide for those very special family members.

We can formulate medication in the form of bullet capsules and suppositories for mechanical delivery, including ones that are discontinued or not commercially available.

USE OF OUR PREPARATIONS: We are not permitted by FDA regulations to provide medications for use in food-producing animals. This includes all meat-producing and lactating animals. When we receive a prescription order for any item that is commonly used in food-producing animals, we may require a veterinarian-signed preparation usage statement.
